#### IB (Ms. Swiger) Presentation

(Focus: Policy alignment and how we incorporate it at BMES)

- What is IB?
  - Buckland Mills has been an authorized IB PYP school since 2013. The PYP offers an inquiry-based, transdisciplinary curriculum framework that builds conceptual understanding to enhance student learning. The framework has 3 pillars: The Learner, Learning and Teaching, Learning Community The framework and programme are guided by the Programme Standards and Principles of Practice and general regulations. The framework is built to support our Purpose, Environment, Culture and Learning.
- IB Policies
  - The International Baccalaureate (IB) has policies for academic honesty, assessment, and more. These policies include guidelines for students, educators, and schools in partnership with PWCS. Our school has the following policies: Academic Integrity Admissions Assessment Inclusion Language Complaint. Our current policies can be found BMES website-About Us-IBPYP-IB PYP Policies and Regulations.
- IB Alignment
  - PWCS Strategic Plan-increase the number of programs to students at all levels. PYP 5 to 9 schools, MYP 4 to 6 schools, additional high school DP program making this rigorous program available to 20% of our student population. PYP schools have begun to align the Units of Inquiry (curriculum) across schools and will be completed this school year. To have organizational coherence amongst the programmes and schools, we are aligning policies across the division.
- Stakeholder Feedback
  - The IB Coordinators at all levels are looking for those who are interested in providing feedback on the policies by 1/16. #### Superintendent's Advisory Council

- Two months ago, they went over all the demographics at the school (diversity, languages, translations) focused on what PWCS must accommodate to support all students and families. They went over test scores amongst the different groups. They talked about a plan to support these students with extension programs and activities.
- Last month, they discussed VALLSS testing it's a diagnostic test to allow teachers to know the areas of concern for the students – teachers are having to learn the new testing.
- The last meeting was cancelled it will be shared at the next meeting.

#### <u>Open Chair</u>

 Mr. Soublo asked about the expectations with devices during Code Orange. What are the criteria to determine what code? – More information on these codes is found on the PWCS website. Code Orange will most likely be used when school is closed for more than 5 days. It would still be up for discussion. Code Orange can be called for any emergency, not only due to weather. PWCS wants to ensure they are prepared if an event ever occurs when schools cannot be open. BMES has developed Code Orange schedules to ensure we are prepared if Code Orange does occur (includes: encore, general education, and special education schedules).
